DECLARATION ON ESSENTIAL BUSINESS TRAVEL OF SHORT DURATION

(- This form needs to be completed and presented at the border -)

This declaration is to be completed by the business partner or employer in Iceland of the third-country national who requests to enter Iceland in business purpose of short duration from a third country to which travel restrictions apply. This declaration is to confirm that the travel is essential, and it cannot be postponed or performed abroad. The final decision to allow or deny entry into the country is made by border guards upon arrival.

(incl. inter alia: journalists, researchers and scientists, professional athletes and their staff for competitions, business trips and meetings)

It is <u>important</u> that foreigners who have not been issued a temporary work permit in Iceland may only work here if: i) the work of the person in question falls under the exemption for short-term employment, or ii) the work of the person in question is not considered to be within the domestic labour market, e.g. players of foreign sports associations and associated staff. - A valid travel document (passport).
- A valid visa (if applicable).
- Declaration from the employer regarding transactions or the work of a foreign national in this country and which cannot be performed later or overseas (see form A).
- Documentation confirming in greater detail the reason for the travel, e.g. meeting or conference schedule, confirmation of sports event, research work or information on the importance of gathering news.
